We inform you that we are conducting a study entitled: “A qualitative study on the representations in European adolescents of Performance and Appearance Enhancing Substances (PAES) in recreational sports contexts, organized by CONI and the Department of Psychology of the Catholic University of the Sacred Heart.

For this reason we invite you to allow your son / daughter to participate in the quantitative study that will be conducted under the responsibility of CONI (Italian National Olympic Committee). Before you decide whether to accept or renounce, please read this document carefully, if you wish to have further information and clarifications you can contact Dr. Matteo Bovis (whose contact details you can find at the bottom of this document), collaborator of CONI, who will dedicate all the time necessary to clarify any doubts.

Are you or your child obliged to participate in the study?

Participation is completely voluntary. Furthermore, if at any time you change your mind and wish to withdraw your son / daughter from the research, you are free to do so.

Premises and purpose of the study

-Purpose: To deepen the sport practice experience of young adolescents, as well as the knowledge and opinions regarding substances called PAES (Performance and Appearance Enhancing Substances), that is, used to enhance performance and / or physical appearance.

-Design of the Study: Quantitative study through online questionnaire.

-Expected duration of the study: 6 months

-Number of participants: approximately 1500 adolescents in 7 European countries. - To deepen the experiences of sporting practice of European adolescents, as well as the knowledge and opinions regarding

substances called PAES (Performance and Appearance Enhancers Substances), that is, used to enhance performance and / or physical appearance.

What will happen if you decide to participate in the study?

The procedure involves the filling of an online questionnaire by adolescents (14-19 years) who play recreational sports. The time required will be around 15 minutes.

What are the possible benefits of participating in the study?

There are no direct benefits for participants.

What are the possible risks / side effects of participating in the study?

Participants are not expected to take risks or suffer any side effects associated with participating in research.

Will you receive the results of the study?

You will receive a written summary of the results in aggregate form (without any individual reference) of the research by email.

Other important information

We inform you that the study will be conducted in accordance with the "Standards of Good Clinical Practice" defined internationally and in compliance with the ethical principles established in the "Declaration of Helsinki" (1964) and subsequent revisions.

Participation in the study

The participation of your son / daughter is completely free and voluntary. This form is intended to ensure that you have received complete information and that you have freely expressed your willingness to participate; it does not imply any commitment on your part to continue the study, it does not constitute a contractual obligation, nor does it represent a waiver of the rights you are entitled to. In the event that you decide to withdraw your son / daughter from the study, after having initially accepted, you can interrupt your participation at any time by notifying the Lead of the study (below) without having to provide a justification. The choice not to participate, or to withdraw after initial acceptance, has no consequences. From an economic point of view, participation in the study does not lead to any type of burden or additional expense for you. Please note that you are not required to participate in this study to receive clinical assistance, or to obtain personal diagnostic benefit.

The Study Protocol in which you are proposed to participate by giving consent for your son / daughter, was approved - together with this document - by the Ethics Commission of the Department of Psychology (CERPS) of the Catholic University of the Sacred Heart.

INFORMATION on PROCESSING OF PERSONAL DATA ex art. 13 and 14 of Regulation (EU) 2016/679 (hereinafter "GDPR")

Dear Sir / Madam,

We inform you that, within the DRAWS Project (hereinafter the "Project" or the "Initiative"), the Italian National Olympic Committee (hereinafter the "CONI") and the Catholic University of the Sacred Heart of Milan (of hereinafter the "University") in their quality of Joint Data Controllers - as per specific agreement, a synthetic copy of which is available at the request of the interested party - will process, for the purposes and methods indicated below, the personal data you have provided upon joining the Project, or acquired in carrying out the interviews that will be carried out in relation to the research activities connected to it.

In particular, the Joint Data Controllers – directly or through their National Division Administrators - will process the following personal data:

- a) personal and identification data (name, surname, e-mail address, telephone)

1. Legal basis and purpose of the processing

The processing of the above data is based on your consent and is aimed at carrying out a scientific research study, as part of the Project as indicated above, through information data collection by means of online questionnaire.

2. Methods of treatment

The processing is carried out by the staff of the Joint Controllers also with the aid of electronic means, by means of the operations indicated in Article 4 no. 2) of the GDPR and precisely: the processing of personal data may consist of the collection, registration, organization, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and destruction of data.

In particular, the aforementioned questionnaires will be available online on the Qualtrics platform.

The data provided will be made non-identifiable, i.e. the collected material will be anonymized and not linked to your identity. This material will be analyzed and processed for scientific research purposes only by the staff responsible for carrying out the Study.

Data processing does not include an automated decision-making process, including profiling.

Adequate security measures will be used to ensure the protection, security, integrity and accessibility of personal data.

3. Mandatory nature of the provision

The provision of the aforementioned data is optional, however any refusal to provide the same will not allow the minor's participation in the Initiative.

4. Scope of data communication

The personal data provided will not be disclosed to third parties, their access being reserved only to the employees of the aforementioned Joint Controllers subject to prior authorization for processing.

5. Transfer of data abroad

5.1. Personal data is stored on servers located in Europe. In any case, it is understood that each Joint Data Controller, if necessary, will have the right to move the servers even outside the EU. In this



case, each Joint Controller ensures from now on that the transfer of data outside the EU will take place in accordance with the applicable legal provisions and in particular those referred to in Title V of the GDPR.

5.2. Apart from the hypotheses referred to in the previous point 5.1. Your data will not be transferred outside the EU.

6. Data retention period

The data collected as part of the Project will be kept only for the time necessary to achieve the purposes for which they were collected or for any other legitimate purpose connected to them and in any case for a minimum period of 5 years (pursuant to Art. 17 of the Deontological Code of Italian Psychologists).

Personal data that are no longer necessary, or for which there is no longer a legal prerequisite for its conservation, will be irreversibly anonymised or securely destroyed..

9. Rights of the interested party

At any time you will be able to know the data concerning you, know how they were acquired, check if they are exact, complete, updated and well kept, request their correction or cancellation pursuant to articles. 16 and 17 GDPR. You will also have the right to receive the personal data you have provided and processed with your consent, in a structured format, commonly used and readable by an automatic device and to revoke any consent given in relation to the processing of data at any time. Pursuant to art. 21 GDPR, you will have the right to object in whole or in part to the processing of data for reasons related to your particular situation. These rights can be exercised against all the Joint Controllers, in accordance with the provisions of the aforementioned joint ownership agreement, through a specific request to be sent by registered letter.
